APPLICANT'S INVOLVEMENT IN EYCA

Please describe your experience within the EYCA network; which EYCA member organisation(s) you were/are involved in and how.

I work in the Deputy General Director of national and international Cooperation of the Injuve. Injuve is the youth body of the Spanish Government in charge of (between others) coordinating youth policies with the Autonomous Communities. My position is Head of Service, and the topics covered by my service are related to coworking with international organizations and the development of youth policies in cooperation with many organizations, such as Council of Europe, EU Consilium, United Nations... The work related to EYCA is one of my main tasks.

In relation to the European Youth Card, Spain is a full member of EYCA, and that carries a series of obligations that the Injuve must face. Currently I am in charge of, among other issues, the relationship with the Autonomous Communities in everything related to the Youth Card, cooperation and interlocution with countries which belong to Group 1. Between my daily work I develop and manage the following tasks such as working in future collaboration agreements, complete management of the economic file of the EYCA fee, dissemination or disclosure of information and youth projects like MI Grants, monitoring the Memorandum of Understanding of the European Youth Card management in Spain, which implies a deep and general knowledge of the work related to EYCA, apart from a complete thorough review of all EYCA legal documentation, etc..

ADDITIONAL RELEVANT EXPERIENCE

Please describe your work and experience outside of EYCA that is relevant for the position you are applying for.

When I was younger I was user of youth card, and not so long ago. It could be said that I know, from the point of view of the customer, what is required or expected of the card. As a result of my long experience with troubled youth in penal institutions, I have learned to obtain from them the necessary information to know what they demand and need, and the most important, to know how to treat them. So I could contribute alternative points of view to Eyca which surely have not arisen before due to the peculiarity of my previous work. Other of my strengths to highlight is that I have a degree in Psychology and, as civil servant in the Spanish General Administration, I know the laws and the administrative language as well as most of the European laws.

As examples of cooperation and teamwork coordination, I could say that in my old job in the government delegation I was in charge of a team whose mission was to prepare everything necessary to hold the general elections, which I can assure involves a great workload.

Going back even further, when I was working in correctional institutions I had the need to learn skills such as negotiation, active listening as well as working under pressure, skills that I do not think necessary to justify for obvious reasons of the content of the job.

MOTIVATION STATEMENT

Please explain your motivation to become an EYCA Board member/President, your plans, your intentions, your hopes, etc.

I want to help young people to lose their fear of change, to get out of their comfort zone, to understand Europe as a whole, where they can unfold their life regardless of where they were born. In short, I understand the youth card as an instrument of cohesion within the European Union and I want to put my two cents in EYCA'S growth. To finish by explaining that I put myself as the main challenge to promote the European Youth Card in this context of the Covid19.
